Opening:

Minutes: Minutes from the February meeting were reviewed. Motion to accept the Minutes was made by Kristi Hoffman. Second: Ashlee Zuvich. All in favor

Principal's Report: Presented by Dayl Lynn Shaddock

- There have been many absences recently due to illness.
- Our musical will be on March 28th.
- PSSAs will begin after Spring Break.
- Our building construction was approved by the board. The last day of classes for our school will be a full day on June 5. Storage pods will be arriving soon so that the staff can begin emptying the building.
- Various staff have been involved in the interview process for the Assistant Superintendent position.

Treasurers Report: Presented by Camille Wenger

- Some of our Giant gift cards were used for food for the Bulldog Ball.
- Boxtops brought in \$1200 less than projected, most likely due to our inability to use incentives. This projected amount had already been adjusted for our decrease in students.
- May Fair is upcoming and will affect our balance.

Motion to approve the January budget was made by Kristi Hoffman. Second: Jill Laws. All in favor.

Cub Scout Pack 196 Report: Presented by Ryan Patterson

- The Pack has been busy getting ready for our pancake breakfast to be held this Saturday.
- Scouts will be volunteering for May Fair and Literacy Night.
- The Pack will be recruiting at Kindergarten registration.
- The Pack is doing well and has many active parents and scouts.

Old Business:

1. Race for Education: T-shirt order forms were sent home.
2. We have many volunteer needs including board positions of: Treasurer, Secretary, Vice President, and President. We are also in need of Chairpersons for Bingo and Race for Education. Flyers were sent home with all students.
3. 600lbs of clothing was donated for our first Community Aide clothing drive.
4. Annie Kids, our first Sporting Hill musical, will be held March 28 at 2:15 and 7:00pm. Admission is free. Money was donated by Senior Helpers to pay for the rights to record the show so that it can be made available to the cast.

New Business:

1. In the past, we have provided May Fair tickets to incoming Kindergarteners at Kindergarten registration. We are expecting approximately 80 students. A motion was made to approve \$400 (\$5.00 per student) for May Fair tickets for incoming Kindergarteners by Ashlee Zuvich. Second: Jenni Gery. All in favor.
2. Mrs. Abelson, our school nurse, is retiring this year. She has been with Sporting Hill for 11 years. A motion to approve \$300 for a retirement gift for Mrs. Abelson was made by Kristi Hoffman. Second: Jenni Gery. All in favor.
3. Our budget for Staff Appreciation week was adjusted for our decrease in students. Some of the funds were already used to provide a coffee truck for the staff and to partially pay for the beginning of the year luncheon for

staff. In May, the PTO typically provides a luncheon, breakfast, snack cart, and various other gifts for the staff to celebrate Staff Appreciation week. Camille Wenger suggested adding to our budget for this category so that we can do what we have done in the past to show our appreciation for our staff. A motion to approve \$800 for Staff Appreciation week was made by Ashlee Zuvich. Second: Kristi Hoffman. All in favor.

4. It was noted that the district calendar has the wrong date for our May Fair. The correct date is May 10.

Motion to adjourn: at 6:58pm was made by Ashlee Zuvich. Second: Jenni Gery. All in favor. The meeting was adjourned.
